UNITAB has implemented the Esker DeliveryWare Platform to automate document delivery

At the end of 2004, UNiTAB acquired Maxgaming, a subsidiary of TAB Limited – an existing Esker customer. The acquisition meant that on January 1st 2005 UNiTAB would embark on a six month migration program to integrate all areas of the two organisations and relocate computer systems from Sydney to the Brisbane head office.

Stephen Lawrie, Group GM Technology for UNiTAB Limited, said: "The magnitude of task ahead of us – to merge all areas of the two businesses – meant that we needed reliable suppliers and partners to see us through the process. We looked to the most successful aspects of the separate businesses to determine our way forward and Esker's solutions had worked well for TAB and stood out as an effective business tool."

Based on the success TAB had achieved with Esker, the solution was implemented across the new and now significantly larger UNiTAB business.
