### SETTING A NEW STANDARD FOR DOCUMENT DELIVERY

For many in the healthcare industry, automated e-delivery of business documents represents a new strategic direction with a lot of untapped value. BlueCross BlueShield of South Carolina, a leading health insurance provider, addressed its evolving document communication needs by adopting Esker's on-premises platform for automated document delivery.

#### The Problem: Paper Dependency

BlueCross BlueShield recognised that manual document delivery processes such as standard mail and fax were impeding communication and delaying business processes. In their State Managed Care department, for example, paper faxes were received at a central fax machine. Medical Service Technicians (MSTs) would pick up faxes several times throughout the day and then sort, review and distribute to staff. Handled faxes would be filed in folders and picked up by MSTs at the end of the day. Faxes would then be sent via manual fax and refiled, indexed, imaged and filed yet again.

#### The Solution: Esker DeliveryWare

To accomplish its goal of increasing efficiency and productivity, BlueCross BlueShield enlisted the help of industry leader, Esker. BlueCross BlueShield implemented the Esker DeliveryWare platform on its premises for intelligently automated document composition and delivery via fax, along with XML, web, email, PDF, archive and more.

Under the Esker DeliveryWare umbrella, the company leveraged the Esker Fax solution for integrated desktop and production faxing. With Esker Fax in the State Managed Care department, designated department contacts retrieve and review faxes sent to group email accounts. The faxes received by this generic account are forwarded to appropriate staff, who then store the information in a template on a shared network drive. A copy is forwarded to the email account for medical record archiving, and completed templates are easily retrieved and faxed to customers.

#### Benefits after Implementation

For BlueCross BlueShield, utilising Esker has meant less paper to be handled or misplaced. Work can now be done from user workstations, and productivity is improved by the rapid exchange of documents. Shared-drive storage and updates enable everyone to view the status of individual cases without having to search for hard copies.
